During the reporting year, StrategEast managed not only to expand and strengthen cooperation its international financial institutions. development agencies, governments, and global IT companies, but also to form a completely new region for the technological map of the world, which, thanks to our efforts, is rapidly becoming a digital single market. Of course, I am referring to the region of the Gulf, the Caucasus, and Central Asia, with a population of over 150 million people united by close cultural traditions. Bringing together the Middle East, Caucasus, and Central Asia, we form the digital single market where intellectual passion, global entrepreneurial skills, and smart money from the Gulf join cuttingedge technologies and innovations from the Caucasus and Central Asia, creating a global center of digital excellence.

In this report, you will find information about a large number of specific efforts that StrategEast has made on our path to forming this single market: organizing visits to the Gulf for delegations from Central Asia and the Caucasus, holding webinars, participating with startups from Eurasia at the main events in the

Gulf countries, and holding a panel on Knowledge as a New Energy within the framework of the StrategEast State and IT Eurasian Forum in Almaty dedicated to the prospects of the region's transition from an economy of natural resources to a knowledge economy. In the course of working on building a single market, we saw that thanks to our cooperation with the countries of Central Asia and the Caucasus, where the IT system was mainly created with participation from American engineering companies, the Gulf countries' digital ecosystem will also be based on products from trusted vendors.

We also work in Eastern Europe, where a full-scale war between the Russian Federation and Ukraine continues. Ukraine's IT industry has become the backbone of Ukraine's digital resistance and digital resilience during this period of Russian aggression. However, no less important is the fact that in wartime, Ukraine's IT industry has been the only sector of the economy where production increased. StrategEast has expanded its support for the IT sector in Ukraine, helping to attract additional investments to the country, promoting the Ukrainian IT industry in old and new markets, and bringing knowledge and experience from Silicon Valley to Ukraine. In November, Warsaw hosted the Ukrainian Digital for Freedom forum, organized by StrategEast in cooperation with USAID and the Ministry of Digital Transformation of Ukraine. We believe that the Forum will be an excellent launch pad for the Digital Marshall Plan for Ukraine's recovery.

StrategEast believes that cooperation between all stakeholders is the key to success in developing Eurasia's IT industry.

Over the past year, we have increased cooperation with international institutions – large-scale educational projects have been implemented in the regional cities of Georgia and Azerbaijan together with the EBRD, and in the spring of 2024 we plan to expand the project to Central Asia. Across Eurasia, we have significantly expanded our cooperation with USAID, jointly implementing, in particular, programs such as training business angels and creating coalitions of donors for IT development.

Cooperation with global IT corporations allowed us to launch a training program for 2,050 students from Uzbekistan and Kazakhstan in modern IT specialties together with Google, become regional partners of the Oracle Academy, and plan the launch of a joint educational program with Microsoft in 2024.

StrategEast is also building ties with Western universities. After the article "Digitalization in Eurasia" was published by prime US outlet Fletcher Forum of World Affairs, I was invited to contribute to Oxford Diplomatic Dispatch, and a guest lectured at the Fletcher School of Law and Diplomacy.

With all of these current and future efforts, StrategEast is proud to be a leading independent institution working to develop the Eurasia's digital economy, in collaboration with international financial institutions, development agencies, global tech companies, and Eurasian governments.

Mr. Tkeshelashvili holds an MA in legal studies from Tbilisi State University and an LLM degree from Emory University in Atlanta.




Daniel A. Witt

Westernization Report 2023



The third edition of the StrategEast Westernization Report 2023 is a unique biannual study providing a comprehensive snapshot of Westernization in post-Soviet Eurasia. In this report, the experts from Eurasian and Baltic countries describe the most important political and economic events that occurred in the post-Soviet region over the last year.

Looking at the events, which will most likely affect the degree of Westernization in their respective countries, the experts singled out the major circumstance impacting almost all of the countries that gained or restored their independence following the collapse of the Soviet Union.

The prior year, 2022, was overshadowed by a singular event, which dominated nearly all of our experts' analytical materials - the war unleashed by the Russian Federation against Ukraine. This reverberated throughout the entire region. The report identifies the consequences of recent global events and their impact on Westernization in the post-Soviet space.

While Russia is currently only waging a full-scale hot ware against Ukraine, it also continues to fight cold wars against every single other country that declared or regained its independence after the collapse of the USSR. Prior to 2022, Russia passed off its attempts at increasing its influence in the region as "cooperation". If the leaders of neighboring countries did not actually believe this, they at least pretended to. Over the last year, we have seen this "cooperation" morph into a series of operations aimed at forcing loyalty. Russia has shown it is willing to weaponize any leverage available to it in these wars. When it comes to energy, our experts from Lithuania, Moldova, and Azerbaijan focused on changes to the energy sector as the past year's main event. Lithuania has completely abandoned the purchase of Russian energy, while Moldova has diversified its supplies, and Azerbaijan has cooperated with the European Union in an attempt to partially replace Russia as a reliable gas supplier to Europe. Ethnic Russian segments of the population, from Latvia and Estonia in the Baltic States to Kyrgyzstan in Central Asia, still play a major role in domestic politics. At the same time, it is clear that in all three countries, experts describe that population's diminishing loyalty to the Russian Federation in the wake of the war in Ukraine.



StrategEast presented the Westernization Report 2023 to the Henry Jackson Society

On July 25, Anatoly Motkin, President of StrategEast presented the key trends unfolding in the Eurasian space based on the results of the StrategEast Westernization Report 2023.

The corresponding roundtable discussion was organized and hosted by the Henry Jackson Society at their London premises and was chaired by Ariella Durban, HJS's Executive Research and Communications Assistant.

The discussion with participation of Eurasian and European diplomats highlighted the importance of cooperation and awareness among nations to navigate the challenges posed by Russia's actions.






























- 1. Eurasian countries that hav enot yet declared developing their IT industry as a state goal are urged to include IT on their list of national priorities.
- 2. Set up an educational system specialized in IT.
- 3. Create special legislation for the IT sector as an essential factor for global IT companies' entry into Eurasian markets.
- 4. Countries need to create national and regional-level venture funds in order to attract investments from global IT companies.
- 5. In order to develop Fintech, governments and local financial regulators are encouraged to create a sandbox for Fintech experiments.
- 6. We encourage international financial organizations and development institutions to support the IT industry more effectively by creating country and regional-level "donor coalitions".

Digital for Freedom Forum in Warsaw

StrategEast signed an agreement with the EBRD on expanding the IT HUB program to 5 regions in Georgia



On December 9, 2022, StrategEast, the European Bank for Reconstruction and Development (EBRD), and Georgian Innovation and Technology Agency (GITA) signed a collaboration agreement on implementing the IT HUB program in Georgia.

The document was signed by Lika Merabishvili, Regional Director, StrategEast; Catarina Bjorlin Hansen, EBRD Regional Director for the Caucasus; Avtandil Kasradze, Chairman, GITA. The event was also attended by Irakli Nadareishvili, the Deputy Minister of Economics and Sustainable Development of Georgia.

The IT HUB program covers 5 regions of Georgia and includes 40 students in each region. The students gain theoretical and practical knowledge that will provide them with skills of executing various complex IT projects. Successful graduates will be employed by different global and local tech companies with the support of StrategEast.

The project is being implemented with financial support from the EBRD in partnership with GITA.



StrategEast IT HUB officially launched in Azerbaijan

StrategEast, in collaboration with the European Bank for Reconstruction and Development (EBRD) and the Center for Analysis and Coordination of the Fourth Industrial Revolution lauched the IT Hub Azerbaijan project.

The official kick-off meeting was held on February, 7, 2023, in Baku, Azerbaijan and was attended by Anatoly Motkin, President of StrategEast; Helen Uvarenko, IT Hub Program Manager at StrategEast; Rovshan Rahimov, Partnership Development Manager at StrategEast; Tamerlan Tagiyev, Executive Director of the Center for Analysis and Coordination of the Fourth Industrial Revolution by the Ministry of Economy of Azerbaijan (C4IR); Kamola

Makhmudova, Head of the EBRD in Azerbaijan, representatives of the Ministry of Science and Education of Azerbaijan, the Ministry of Digital Development and Transport of Azerbaijan, and rectors of key Azerbaijani universities.

The project envisages free IT trainings for young Azerbaijanis from remote regions including the cities of Ganja, Sumgayit, Lankaran, Mingachevir, Shirvan, and the Nakhchivan Autonomous Republic. IT Hub Azerbaijan provides training for 80 students in 7 specialties.

The trainings led by international experts in computer science, programming, business analysis, and other disciplines, will be conducted virtually and last 11 months.

This is the second enrollment of students for StrategEast IT Hub in Azerbaijan. The first one took place in 2021.

StrategEast took part in Silicon Valley Startup Grind




StrategEast discusses joint activity in Georgia with the Asian Development Bank


Mr. Motkin, StrategEast President, shared his insights and vision for the future of Bahrain's IT industry, aligned with the Economic Vision 2030.



StrategEast took part at the online discussion with CAREC Institute's report on Digital FDI Ecosystem presentation



Speaking at the webinar Digital CAREC Virtual Policy Dialogue: Digital FDI Ecosystem, Anatoly Motkin, StrategEast President, offered his views on policy recommendations aimed at attracting investment in the digital economy and how cross-regional collaboration fosters ecosystem growth.

Mr. Motkin shared what has to be done to attract leading international IT companies to the CAREC countries to speed up regional integration, address the lack of digital skills, foster investment in the tech sector, and raise venture capital.

By addressing these isues, the CAREC region would attract more foreign direct investment and foster inclusive growth.

An open dialogue session featured distinguished speakers – Norbert Funke, Director, IMF, CCAMTAC; Soo Hyun Kim, Economic Affairs Officer, UNESCAP; Mikhail Bunchuk, Senior Digital Development Specialist, the World Bank, Central Asia Regional Office; John Beirne, Vice-Chair of Research and Senior Research Fellow, ADBI; Syed Hassan Alsagoff, Manager of Science, Technology and Innovation Devision at Cooperation and Capacity Development Department at the Islamic Development Bank; Imed Drine Alsagoff, Lead Economist for MENA and Europe at the Islamic Development Bank.

The discussion was moderated by Ayoob Ayoobi, chief of Capacity Building Division, CAREC Institute.

StrategEast's President proposed key strategies at IsDB Digital Inclusion



Anatoly Motkin, President of StrategEast, presented proposals during his participation in the 3rd IsDB Digital Inclusion Technical Working Group (IDITWG) meeting, which was held in Jakarta, Indonesia on October 20, 2023.

The meeting took place on the sidelines of the Digital Transformation Summit 2023 Jakarta, a collaborative event co-organized by the Ministry of Communications and Informatics of the Republic of Indonesia, along with various government entities and private sector representatives. It marked a significant occasion as the IsDB launched its new Digital Inclusion Strategic Partnership Program (DISPP), aimed at supporting and accelerating the execution of the Bank's Digital Inclusion Strategy for 2024-2027 across six countries. This program includes pilot initiatives with international organizations, Multilateral Development Banks (MDBs), and United Nations agencies.

Mr. Motkin suggested key additions to the IsDB's Digital Inclusion Strategy for the upcoming years. His proposals encompassed a range of initiatives, including the incorporation of regional educational programs and cooperation with universities, global educational collaborations, the promotion of regional and transnational partnerships, and the development of an entrepreneurial mindset and startup ecosystem. These recommendations hold the potential to reshape the digital inclusion landscape and contribute to sustainable development across the regions under IsDB's purview.

StrategEast discussed collaboration opportunities with the Islamic Development Bank

The Billion in the Distance: Central Asian IT Exports and Strategies for Growing Them

StrategEast issued the first regional report and policy recommendations, "The Billion in the Distance: Central Asian IT Exports and Strategies for Growing Them", prepared with the support of USAID and the EBRD.

We wrote this report to examine how the export-oriented IT sector has been developing across all five Central Asian countries, where it stands today, and what might lie ahead. What are the export volumes? What have been the growth rates, and what is driving this growth? What has already been done, and what else could be done? In other words, what is the big picture as the region's export-oriented IT sector begins to come into its own, with single-digit millions of exports turning into tens, hundreds, and eventually, perhaps, billions and beyond?

To answer these and other questions, we combed through numerous data sources and, most importantly, talked to more than 40 experts from every country in the region, including government officials, policy experts, and CEOs and senior managers of the largest global IT companies operating in Central Asia, as well as local tech entrepreneurs.

The result of this work is the first in-depth study to examine the Central Asian region's export-oriented IT sector as a whole. The report's analysis and recommendations will help country governments, international development agencies, financial institutions, and global and local IT players find the right tools to grow an export-oriented IT industry in the Central Asian region. These tools will be helpful for developing country and regional strategies by all the stakeholders listed here.




StrategEast Westernization Report 2023

StrategEast has released its flagship bi-annual Westernization Report 2023, in which experts from Eurasian and Baltic countries describe the most important political and economic events that occurred in the post-Soviet region over the last year.

The experts analyzed the events that will most likely have an impact on the degree of Westernization in their respective countries, and singled out the main circumstance affecting almost all of the countries that gained or restored their independence after the collapse of the Soviet Union.

The prior year, 2022, was overshadowed by a singular event, which dominated nearly all of our experts' analytical materials - the war unleashed by the Russian Federation against Ukraine, which reverberated throughout the entire region. The report identifies the consequences of recent global events and their impact on Westernization in the post-Soviet space.


