#### X Developing a special tax and legal regime

We assist governments with developing incentives for global IT companies to launch their operations on local markets. That includes tax reductions for export companies and streamlined work permits for foreign professionals. The new legislation allows and encourages local IT companies to register their intellectual property in the country and evolve from a service model to a product one.

#### "Jobs upon graduation" educational program

StrategEast IT HUB students across Eurasian countries are trained by high-level practitioners working for leading global IT companies. Within 6-9 months, they are able to acquire a new IT profession. Our students get their first job upon successful graduation, and are able to remain in their home country and even their hometown. Additionally, every job created in the IT industry creates 5 more collateral jobs in non-related economic sectors.

#### Startups acceleration

StrategEast's cooperation with the leading Silicon Valley-based accelerator provides an opportunity for startups from Eurasian countries to go global. Our accelerator leads startup founders from taking part in an initial online boot camp all the way to pitch sessions with Silicon Valley investors. We not only train young entrepreneurs in the soft skills they need, but also provide the most successful of them with a unique opportunity to reach international markets.

#### Advocacy of the region as a trusted IT destination

We attract the global IT industry's attention to the Eurasian region's advantages. Local government officials, IT parks, and IT industry associations' representatives, along with the local entrepreneurs get the opportunity to present the advantages of their country at our virtual and in-person events. We assist Eurasian countries with creating a well-balanced ecosystem and then sharing it with the global tech community.



#### Public events supporting the IT industry

Our main public event – the StrategEast State and IT Eurasian Forum – is held annually in different countries around Eurasian region. The Forum is a unique platform that brings together global and local IT companies, government officials, international financial institutions, and global development agencies. Throughout the year, Eurasian country representatives are regular participants on the StrategEast.Live panels, discussing IT ecosystem development.

#### Venture capital development

In 2021, the Catapult Eurasia venture fund was launched to fund startups from the region. The Fund was established as a result of a collaboration between the Silicon Valleybased Catapult Ventures, leading startup accelerator from Silicon Valley, and StrategEast. Currently, Catapult Eurasia collects funds for first closings in various subregions of Eurasia – Central Asia, the Caucasus, and Eastern Europe. The fund's main aim is to combine Catapult Ventures' global expertise with local investment potential to form and accelerate Eurasia's startup industry.


#### Green and social impact

# GEORGIA

#### The government reduced tax rates to 5%

At the StrategEast 2020 Forum in Tbilisi, the Georgian government announced a special tax regime for international IT companies, thereby reducing their tax from 20% to 5%.

#### StrategEast IT HUB with EBRD

In February 2020, the first StrategEast IT HUB was opened in Tbilisi. In just two years, thousands of students have been trained and received high-paying jobs in Georgia. In 2023, IT HUB has expanded its activity to regional centers, with support from the European Bank of Reconstruction and Development.

#### Oracle Academy launch

The Oracle Academy program will equip Georgian universities with comprehensive resources, including a full academic curriculum in key Oracle technologies,

#### 🔗 First startup acquisition

A full-scale startup acceleration program has been launched in collaboration with Silicon Valley-based accelerators USMAC. One year later, the first Georgian startup was acquired by US company SpinCar.

In 2023, StrategEast presented startups from Georgia at BIBAN 2023 - the key startup tech event that attracts global stakeholders in Riyadh, Saudi Arabia.

#### Promoting Georgia as a trusted IT destination

In cooperation with the state agency Enterprise Georgia and the Georgia's Innovation and Technology Agency, we have launched a program aimed at attracting international IT companies. Within a year, more than 30 large tech companies have opened their offices and created 2,000 high-paying jobs locally.

#### StrategEast State and IT Eurasian Forum in Tbilisi

The COVID-19 outbreak dealt a heavy blow to the Georgian economy. Against that backdrop, the StrategEast State and IT Eurasian Forum was held in Tbilisi with the lead topic, "TECHNOLOGY AS A REMEDY". For the first time, the Georgian government declared the IT industry to be one of the key new pillars of the country's economy.



#### Hackathon series with Google

StrategEast and Google, supported by USAID's FGI, kicked off the "Build with AI for Sustainable Development" hackathon series. This initiative aims to leverage Google AI to tackle climate issues and promote sustainable development.

#### Contribution to the Digital Resilience in Eurasia study

The Georgian Data Exchange Agency took part in the StrategEast and The World Bank joint report entitled Digital Resilience in Eurasia.

#### Representing Georgia on global platforms

In 2024 in partnership with Oman International Trade and Exhibitions StrategEast organized the participation of Georgia at COMEX, a premier technology show held in Oman.



#### IT professionals' social contribution

StrategEast's report "Changing Economy – Changing Society", published in 2018/19, explored the IT community's significant role in transforming public life in Armenia.

#### Al regulatory gaps, ethical concerns, and public trust

StrategEast, with support from RECONOMY, a program of SIDA, has launched the AI Policy Dialogue Initiative to accelerate AI adoption and enhance government preparedness.

#### StrategEast and Google hackathon

#### Special legal regime established

In 2021, Diia City, a special legal regime for the IT industry, was established in Ukraine, providing a reduced 5% tax rate for IT companies and the use of British law for intellectual property protection, along with other advantages. StrategEast in cooperation with Oxford Economics presented a case study report to international financial institutions and global development agencies on the positive impact of de-shadowing Ukraine's IT sector following the adoption of the Diia City law.

#### 🮯 IT HUB for IDPs in Ukraine

With support from GIZ, StrategEast has launched an IT job creation program for IDPs. We are working with a major global development agency to implement a "training for trainers" program for university professors from around Ukraine.

#### 😰 Digital Marshall Plan for Ukraine

The Digital Marshall Plan for Ukraine was initiated by StrategEast in May 2022 in an oped published by the Atlantic Council in its UkraineAlert blog. At the Ukraine Recovery Conference held in Lugano in July 2022 together with the Ministry of Digital Transformation of Ukraine, we formed an advisory group consisting of VPs from leading global tech companies to accelerate Ukraine's digital transformation.

#### Ukrainian Digital for Freedom Forum took place in Warsaw

In 2023 the StrategEast Digital for Freedom Forum took place in Warsaw, Poland. In 2023 StrategEast co-organized a Ukrainian side event at in the Web Summit in Lisbon. In 2019 the first StrategEast State and IT Eurasian Forum was held in Ukraine.

#### Ø Ukrainian startups in the Gulf

In 2023, StrategEast presented startups from Ukraine at BIBAN 2023 - the key startup tech event that attracts global stakeholders in Riyadh, Saudi Arabia.

#### Ukrainian IT entrepreneurs delegation in Washington

In April 2024 in Washington the StrategEast's delegation, comprising top executives from leading Ukrainian IT companies engaged with key stakeholders in the US state institutions and major businesses. This visit, part of the Digital for Freedom initiative, focused on building collaborative platforms, exploring market opportunities, and securing investment for Ukraine's IT industry.

#### Reports and analytics

In March 2022, together with the Ministry of Digital Transformation, StrategEast released the "Ukrainian Digital Resistance to Russian Aggression" report, documenting the digital ecosystem's vital contribution to Ukrainian resilience during the Russian invasion. Ukraine became a contributor to the joint report with the World Bank entitled "Eurasia's Data Economy". Another report devoted to the Ukrainian IT industry entitled "Innovative Ukraine" was released jointly by StrategEast and the Kyiv-based IT cluster "Unit City".



#### Jobs upon graduation

Together with Tekwill and with support from USAID and Sida, we have trained students from Moldova in new IT specialties at the StrategEast IT HUB. All graduates have already been hired for their first jobs in the IT industry without having to relocate from Moldova.

#### 😰 Building a coalition of donors

The quarterly meetings of international donors dedicated to the development of the Kyrgyz IT industry, organized jointly with the UNDP and Kyrgyz Software and Services Developers' Association, brought together representatives of more than 20 interested organizations.

#### StrategEast State and IT Eurasian Forum in Bishkek

In collaboration with Ukraine's Ministry of Digital Transformation, facilitated a series of high-level meetings in Qatar, Saudi Arabia, and Oman.

### LATIN AMERICA



StrategEast also launched its activities for the first time in a new region – Latin America. We provide countries in the region with assistance in preparing tax and legal regimes to attract companies currently operating in Eurasia. StrategEast has already discussed with public and private sector representative to create such conditions in Chile, Colombia, the Dominican Republic, Guatemala, Panama, and Paraguay.

A webinar for LATAM countries on "How to create conditions attractive to foreign IT companies" was held in 2022 for representatives of Eurasian countries and the global IT industry, as well as international donors to share their best practices in creating IT ecosystems.
