uring the time that has passed since our previous report, StrategEast has managed to achieve one of its primary objectives. That objective was to convey and impress upon a significant number of Western policymakers the understanding that the key to success of US and European policies in the Eurasian and Baltic region is to facilitate economic transformation.

The transition of Eurasian and Baltic countries from natural resources-based economies to knowledge-driven ones is exactly what will lead to the value transformation that the West is so interested in - reinforcing the values of the rule of law and intellectual property protection in the region's countries.

StrategEast intends that its contribution to this transformation will be its flagship program, Global Minds Initiative, which we have presented during the reporting period to many key stakeholders whose assistance is critically important for the successful implementation of the program's projects. Among those stakeholders are the World Bank, USAID, EBRD, Chatham House, BCIU, representatives of relevant ministries in Eurasian and Baltic countries, a number of major IT companies operating in the region, and heads of local IT clusters. The first specific steps towards the implementation of Global Minds Initiative were the result of such meetings and discussions:

- In the countries of Central Asia and Transcaucasia StrategEast is in talks with U.S.-based donor organizations regarding the financing of the project to create a network of IT HUBs - educational centers of a new type. This project was developed jointly with EPAM, the largest American engineering company operating in the Eurasian region. Thanks to this IT HUB system being created by StrategEast in collaboration with EPAM, the local youth will be able to not only acquire modern, market-driven IT skills, but also find their first jobs or the first investments into their start-ups;

- In Ukraine, StrategEast has initiated international support for the adoption of the law "on the taxation of the IT industry." The aim of this law, which is sponsored by the Ukrainian Parliament's relevant committee and the IT Association in Support of Bill 10094, is to make the local IT industry completely transparent for government agencies, while maintaining excellent prospects for its further development;
- We have commenced the preparations for the first StrategEast State and IT Eurasian Forum, where we will bring together all institutions interested in developing the IT industry in Eurasia. The invitees will include representatives of Western institutions, governments of Eurasian countries, and the global and local IT industries. The forum will take place in Kyiv in early November of this year and will be dedicated primarily to discussing the special aspects of legislation governing the IT industry;
- A separate event, which we at StrategEast are preparing together with the USTR, will be devoted to the problem that stands in the way of cooperation between Western companies and the Eurasian IT industry - the problem of intellectual property rights protection.

Since StrategEast's Global Minds Initiative program has a pronounced technical emphasis and its implementation requires the assistance of world-class experts in this field, we have deemed it necessary to form a separate Advisory Board for this program. Among the esteemed specialists who have agreed to be on this Board are Arkady Dobkin, President of EPAM Systems, Talmon Marco, co-founder of Viber and Juno, and Dr. Gregory Asmolov, Fellow at King's College London. StrategEast is in talks with several other influential representatives of the IT industry and Western institutions interested in the development of IT in Eurasia regarding joining the Advisory Board.

We have continued to popularize in our media publications the idea of transforming society through the development of a knowledge-driven economy. For instance, the Atlantic Council has published in their blog my article on the new prospects of developing the knowledge-driven economy in Ukraine; as such prospects have opened up following the recent change of power in the country. (As a result of this power change, an industrialist president was superseded by a president who is well acquainted with the issues of intellectual property rights protection.)

This February, StrategEast published the first Westernization Report - a continuation of our work on the systemic study of the processes of social transformation and the spread of Western values in Eurasian and Baltic countries. The report was a logical continuation of the Westernization Index, which was published last year. This time our experts did not calculate the level of Westernization of the subject countries, but instead brought to light the process trends.

I express the most heartfelt gratitude to the members of the StrategEast Advisory Board for your trust, valuable advice, and support for our initiatives. Stay with us!

StrategEast Westernization Report 2019



In February of 2019, StrategEast presented its Westernization Report 2019, in which the experts from Eurasian and Baltic countries describe the most important political and economic events that occurred in the region in 2018.

The experts selected a wide variety of events, which will most likely affect the degree of westernization in their respective countries - from the transition to the Latin alphabet in Kazakhstan to blockchain innovations in Lithuania, and from tax reform in Uzbekistan to the peaceful revolution in Armenia. It is not easy to discern clearly defined tendencies in Eurasian and Baltic countries development from this vibrant variety; however, there are two critically important conclusions.

First, the region as a whole is demonstrating positive trends. In nine of the fourteen countries studied, events selected by our experts will undoubtedly facilitate further progression towards Western values. In two cases - the constitutional reform review in Georgia and measures to battle corruption in Kyrgyzstan - it would be premature to make any inferences about potential outcomes. In the process of implementing those legislative measures, much will depend not just on the authorities, but also in equal measure on the activeness of the civil society, which will need to "protect" the results of those reforms.

The second important tendency is that, in the majority of countries, events which had a positive effect on the degree of Westernization were initiated by the government. While it was logical to expect that from the obvious leaders of our rating - Estonia and Latvia, and to some degree from Ukraine - the actions of the governments of Kazakhstan, Uzbekistan, Azerbaijan, and Belarus once again proved that "top down westernization" was possible in countries with a wide variety of political systems.

StrategEast Westernization Award

In February, 2019 StrategEast announced its Westernization Award 2018 nominees. The Westernization Award was established for significant contribution of politicians, business representatives and civil activists in creating closer ties between Eurasian and Baltic countries and the Western World. It was presented in 6 categories: **Economic Westernization**, **Political Westernization**, **Legal Westernization**, **Westernization** of **Lifestyle**, **Language**

and Culture Westernization, and Lifetime achievement.

NOMINEES IN 2018 WERE:

Economic Westernization -

Shavkat Mirziyoyev, President of Uzbekistan

Mr. Mirziyoyev had transformed Uzbekistan by bringing equal opportunities and taking serious steps in terms of Uzbekistan economic development. He has changed Uzbekistan's decision-making processes, encouraged political competition and strengthened civil society.



StrategEast President Anatoly Motkin presented the Westernization Award for President of Uzbekistan Shavkat Mirziyoyev. The Award was presented to Javlon Vakhabov, Ambassador of Uzbekistan to the U.S. in Washington on May 7, 2019.

Political Westernization -

Lifetime achievement - Toomas Hendrik Ilves, former President of Estonia



They are joined by Dr. Gregory Asmolov from King's College London, whose work focuses on how information technologies, specifically social media and crowdsourcing platforms, constitute the role of individual users and crowds in crisis situations.

Board members will contribute their professional expertise in the IT area and assist StrategEast in implementing the program in the Eurasian and Baltic region.



StrategEast Young Leadership Program 2019

StrategEast Young Leadership Program was held for the second time in 2019 in the United States. The Program is designed for young deputy ministers of Eurasian and Baltic states, in order to provide a deep insight into how internal processes in the U.S. government system works and what the role of governmental authorities is in economic processes.

The program took place over a week-long visit to the United States, including training events led by high-level US officials and analytical community representatives that provided deeper insight into the interaction between state and business.

The main goal of the program is to help the participants to gain new instruments and to broaden their networking

for the development of economic relations between their countries and the U.S. This year program was focused on innovations, knowledge-driven economy and tech development.

Open World Leadership Center and StrategEast were hosting the second Young Leadership Program between June 2-9, 2019.

During the program, the Deputy Ministers met government officials, and representatives of civil society and the private sector. The participants were also divided into two groups and spend several days in home stays – in Philadelphia, PA, and Richmond, VA. The purpose of this part of the program is to familiarize participants with the system of interaction between local and federal authorities.

In the Media

StrategEast continues to spread its program ideas through Op-Eds and interviews in various media outlets. In November, 2018 the Modern Diplomacy published StrategEast President Anatoly Motkin's Op-Ed "Developing the IT sector will make Central Asia more united and independent", in which, Mr. Motkin calls Central Asia the new "IT tiger". Yet, in his opinion, the region may be interesting to the world industry's giants only as a united region, and "they must view it as such already, by extending a certain credibility to the new economic initiatives originating in that region.

This means opening regional offices in the local IT clusters and entrusting them first with outsourcing and then with R&D, serving as evangelists of the new economy in contacts with representatives of the Central Asian countries' governments, and considering the possibilities of investing into local


startups jointly with governments."
In March, 2019 the Qazaqstan TV-channel released an interview with Amb. Michael Brodsky, StrategEast CEO, in which the Language and Cultural Westernization Award to the Director of Akhmet Baitursynov Institute of Linguistics Erden Kazhybek was discussed. Mr. Kazhybek has been awarded for his significant contribution to the Latinization of the Kazakh alphabet.

In his piece for the Atlantic Council blog, published in May 2019, Mr. Motkin shared his thoughts on how the West can assisit to transform the Ukrainian economy to a knowledge-driven model. He believes, the IT sector, along with other sectors of the knowledge-driven economy, "has a chance of becoming a "Western oasis" in the Ukrainian economy: corruption-free and ensuring significant economic growth throughout

the country, and creating jobs in related sectors."

In its article issued in July 2019, the US News and World Report underlined, that with corruption on the rise in post-Soviet Eastern Europe and Central Asia, information technology looks like the safest bet for foreign investors. It also covers the presentation of "Changing Economy, Changing Society" report at the Atlantic Council.

In his Op-Ed for the Atlantic Council blog, Anatoly Motkin explained the importance of IPR protection for economic growth in Ukraine. "Investors want predictability and protection. The lack of a system that protects intellectual property directly affects trade relations between Ukraine and the United States, but even more, it limits Ukraine's ability to attract foreign investment.", - Mr. Motkin writes. He adds that reforming the system of intellectual property rights will give Ukraine a real chance to attract investment into the local IT industry.




Horton Beebe-Center

Ms. Cagan, a native Chicagoan, has a BA and MA from the University of Iowa and completed additional post-graduate work at the University of Chicago towards her doctorate, where she was named the first woman fellow for the prestigious Armed Forces and Society Consortium.



Michael Haltzel

Senior fellow, Johns Hopkins School of Advanced International Studies Mr. Haltzel has made a great contribution to the establishment of peace and security in the region of Eastern Europe after the fall of the communist regimes. He is a recipient of state decorations from many Eastern European States, has served as OSCE monitor for the first post-war elections in Bosnia, and is the author or editor of ten books on European history and international relations. Mr. Haltzel holds Ph.D. in history from Harvard University.



Roza Otunbayeva

President of the Kyrgyz Republic (2010-2011) Roza Otunbayeva has taken an active role in democratic changes in Kyrgyz Republic. Ms Otunbayeva has served as Vice-Prime Minister and Foreign Minister, the first Kyrgyz Ambassador to the United States and Canada (1992-1994), and later to the United Kingdom and Northern Ireland (1997-2002). From July 2010 to December 2011, Roza Otunbayeva served as President of the Kyrgyz Republic. During 2002-2004 she worked as Deputy Head of the Special Representative of the UN Secretary General in peacekeeping mission to Georgia before returning to Kyrgyzstan.

She holds a PhD in Philosophy from Moscow State University



Mark Pritchard

Member of Parliament of the United Kingdom, OSCE PA Special Representative for South East Europe Mr. Pritchard has extensive international experience, being the first MP to serve consecutively, on the NATO, Council of Europe, and the Organisation for Security and Cooperation in Europe Parliamentary Assemblies.

Mark is a former Deputy Chairman of the Conservative Party's International Office - and has advised political parties throughout Europe and sub-Saharan Africa.

He has also monitored elections on behalf of the Council of Europe and the OSCE throughout Europe, North America, and post-Soviet countries. He holds two Masters Degrees in International Diplomacy and Management and International Marketing.



David Tkeshelashvili

Chief of Staff to the President of Georgia (2010-2013)

Mr. Tkeshelashvili instituted a series of structural and policy reforms for decentralization and sustainable regional development in Georgia.

Mr. Tkeshelashvili led regional development and local selfgovernment reform process, first as a State Minister for Regional Issues, later under his leadership new office, Ministry of Regional Development and Infrastructure was created. He served as a minister of the newly established agency till 2010.

He holds Master of Arts in Legal Studies from Tbilisi State University; and LLM degree from Emory University in Atlanta.



Daniel A. Witt

President, International Tax and Investment Center

Working on the drafts of tax codes of many countries of the former USSR, Mr. Witt always followed the principles of good practices. StrategEast State and IT Eurasian Forum, Ukraine

StrategEast will host the first State and IT Eurasian Forum in Kyiv, Ukraine, in November 2019, jointly with Ukraine's government authorities.
